As disclosed on 01.04.2022, as Koç Holding's direct and indirect shares in Yapı ve Kredi Bankası A.Ş. (YKB) exceeded the 50% threshold defined in CMB's Communique on Takeover Bids following the purchase of YKB shares as of the same date, a mandatory tender offer has been triggered for Koç Holding for the shares of other YKB shareholders. In this respect, Capital Markets Board (CMB) approved the application of Koç Holding for the mandatory tender offer.

The information memorandum for the mandatory tender offer as approved by CMB and the request form is attached. These documents will also be available on the websites of Koç Holding and Yapı Kredi Yatırım Menkul Değerler A.Ş., who will be acting as the intermediary institution in the tender offer (www.koc.com.tr and www.ykyatirim.com.tr).

The mandatory takeover bid price has been determined as TL 2.2757 taking into account the TL 0.1183845 dividend distribution made by YKB on 13.04.2022.

The tender offer will last for a term of 10 business days, starting on 16.05.2022 and ending	on 30.05.2022 at 17:00.
